The **Superintending Engineer, P.H. Circle, Bhubaneswar, Odisha** on behalf of Governor of Odisha invites **Lump Sum Bids** through **e-Procurement** in conformity with the terms and conditions of the Detailed Tender Call Notice (DTCN) in Two Bid system (Part-I: General & Technical Bid and Part-II: Price Bid) from “**Special Class**” & “**Super Class**” **Contractors** registered with the Odisha State Government and Contractors of equivalent grade/class registered with Central Government/ any other State Government/ MES/ Railways and Reputed Engineering Firms having experience and expertise in Design, Construction, Testing & Commissioning of Similar Type of Works and fulfilling minimum eligibility criteria as stated hereunder and other detailed qualifying requirements given in the DTCN on **EPC Contract (Turnkey Basis)** to be eventually drawn up in the standard G-2 Contract Form of Odisha PWD. The bid should be submitted on-line in the website www.tendersorissa.gov.in by eligible class of contractors. The bidders should have the necessary Portal Enrolment (with his own Digital Signature Certificate). The registered bidders of outside Odisha can also participate in this process, after necessary Portal Enrolment, but shall have to subsequently undergo registration with the appropriate authority of the State Government before signing agreement.

3. The bidders desirous to participate in bidding must possess compatible Digital Signature Certificate of Class-II or Class-III and should follow the changes / modifications / addendum to DTCN if any.
- 4.a) The bidders have to submit the D.D. in favour of **Executive Engineer, P.H. Division, Puri payable at Puri** towards cost of Tender Paper and E.M.D. in approved form (**As per DTCN Section 2(B), Clause-23.1**) before the Tender Opening Authority i.e., **Superintending Engineer, P.H. Circle, Bhubaneswar, Odisha (as per critical dates mentioned below).**


- b) The scanned copy of Registration certificate, VAT, PAN, affidavits including all required papers up loaded through website should be produced in original to **Superintending Engineer, P.H. Circle, Bhubaneswar, Odisha** for verification before opening of Price Bid. Otherwise the tender will be rejected.

6. **Minimum Eligibility Criteria :-**

- i) **The Firms/ Companies/ Registered Contractors should have successfully Completed & Commissioned Works of similar type valuing not less than Rs.97.91 Lakh (30% of the estimated cost) in any one year during the last 5 (five) years.** The firm shall have to submit the performance certificate of the works constructed by them for satisfactory performance from appropriate authority means the Authority not below the rank of Executive Engineer or equivalent of Govt. Of Odisha / any other State Govt. / M.E.S. / Central Govt. / Railways / any other State & Central Govt. Undertakings. Weightage @ 10% per year shall be given on the value of the completed work in the preceding years.
- ii) **The Firms/Companies/Registered Contractors should have annual financial turnover of not less than Rs.130.55 Lakh (40% of the estimated cost) in any one year in civil construction works during last 5 (five) years and the turnover need to be certified by Chartered Accountant. Weightage @ 10% per year shall be given on the annual turnover of the preceding years.**
7. **The bid for the work shall remain open for acceptance for a period of **120 (One Hundred Twenty) days** from the date of opening of price bids. If any Bidder / Tenderer withdraws his bid / tender before the said period or makes any modifications in the terms and conditions of the bid, the said earnest money shall stand forfeited.**
8. **Other details can be seen in the bidding documents, which is available in website www.tendersorissa.gov.in.**
9. **Subsequent corrigendum if required shall be appeared in the website.**
10. **Authority reserves the right to reject any or all the tenders without assigning any reasons thereof.**
