**N.B:- Eligibility criteria**

- 1. The contractor should have minimum experience in execution of work such as laying of different dia C.I. pipe / M.S. pipe or similar type of works as well as civil works.**
2. Bid documents can be had in the office of Assistant Engineer, P.H. Sub-Division, Jeypore and office of the undersigned during office hours every day except on Sundays and public holidays till last date of sale and receipt of tender papers.

3. Bids must be accompanied by security of the amount specified for the work in the above table of minimum one year valid in shape of NSC / Postal Saving Pass Book / Post Office Time Deposit / K.V.P. / Deposit Receipt in Schedule Bank duly pledged in favour of Executive Engineer, P.H. Division, Koraput.
4. The bid documents shall be sold during office hour's **upto 26.12.2013** in the office of the Executive Engineer, P.H. Division, Koraput & A.E.P.H, Sub-Divn, Jeypore on payment of cost as indicated above table in shape of Cash / Account Payee Demand Draft (Non-refundable) drawn in favour of the Executive Engineer, P.H. Division, Koraput. & Payable at Koraput.
5. Bids shall be received **upto 27.12.2013** in all offices, during office hours where the bids have been notified to be sold through Speed Post / Registered Post / By Person. Tender received after due date & time shall not be entertained and the authority shall not be held responsible for delay or missing of tender during transit. Telegraphic tenders shall not be entertained.
6. Bids must be delivered in the tender box having Identification No: 04/SPH (K).
7. Attested copies of valid Registration Certificate, Pan Card & VAT Clearance Certificate must be furnished alongwith the tender.
8. The Bids will be opened on **28.12.2013 at 11.30 A.M.** in the office of the undersigned only, in the presence of the bidders who wish to attend. If the office happens to be closed on the date of receipt and open of the bids as specified, the bids will be received and opened on the next working day at the same time and venue.
9. Other details can be seen in the bidding documents.
10. Any amendment to codal provisions by the Government during the period from sale of tender till acceptance by the competent authority shall be binding upon the tender.
11. Validity of the tender should be **90(Ninety)** days from the date of receipt of tender.
12. The tenderer has to sign in each page of the tender documents with seal. Cutting / Overwriting / Correction if any should be initialed by the tenderer.
13. Conditional tender shall be out rightly rejected.

14. The tenderers are not required to write their name on the outer cover containing the bid documents. They are only required to write the name of the work and the authority who had issued the tender.
15. An affidavit towards authentication of document must be attached with the tender.
16. Engineer contractor who are willing for exemption of EMD should furnish an affidavit regarding no of tenders awarded to him with exemption of EMD in the current financial year & produce Original Contractor License at the time of opening of tender.
17. The authority reserves the right to reject any or all the tenders without assigning any reason thereof.
